#### **CEO's Message**

As we say adieu to 2024, I would like to take this opportunity to thank all our customers and well-wishers for their kind support throughout our journey this year. It has certainly been a challenging year for the shipping industry as a whole. We have witnessed freight rates soar, especially to US destinations, with no immediate respite in sight. The ongoing geopolitical tensions, particularly in the Middle East, have posed additional challenges. Shipping lines have had to reroute vessels



to avoid the Suez Canal, which has resulted in transit times increasing by two to three times. To cope, carriers have needed to deploy more ships and containers to maintain rotation.

The rerouting via the Cape of Good Hope has led to approximately 1.2 million TEUs being removed from container supply, further tightening the global shipping capacity. In addition, the rising cost of insurance and other operational expenses have placed further financial strain on the industry. Air freight has also faced similar difficulties, with many carriers cutting back on their schedules. With fewer payloads available, air freight rates have remained high. As a result, we expect shipping costs to stay elevated in the first quarter of 2025 due to these ongoing challenges. Key factors driving this include US tariff policies and the geopolitical tensions in the Red Sea region.

Despite these obstacles, like the resilience of a palm tree that grows notwithstanding the "strongest storm" and "biggest wind" we stayed committed to providing the best possible service to our customers. While we have no control over carrier pricing strategies, we are confident in our efforts to negotiate hard on behalf of our clients, securing space and obtain favourable rates wherever possible.

In the year 2024, in addition to handling regular shipments, Team CSL successfully executed several important project shipments. These included logistics for the Indian Navy, shipments to war zones in Jordan for HLL, and securing a UN contract to supply rice and medicines from India to Africa. We are proud of these accomplishments, which reflect the strength and adaptability of our team.

Looking ahead to 2025, we are ready to face new challenges with the same determination and resilience. We remain committed to offering exceptional service and to negotiating the best outcomes for our customers.

#### GLOBAL BYTES

#### **Global Outlook for 2024**

The liner shipping industry is poised for a record-breaking year in 2024, marking its most profitable period outside the COVID-19 pandemic. Recent reports from Splash247 indicate that the sector achieved an impressive income of \$26.8 billion (£21.2 billion) in the third quarter, reflecting a 164% increase from the previous quarter and an astonishing 856% rise year-on-year. This remarkable growth is primarily attributed to the on-going Red Sea crisis and heightened shipping volumes across various trade lanes. Notably, the peak season commenced earlier this year, with freight rates surging significantly in May and June due to extended transit times.

#### **Developments in the UK**

In the UK, the Gemini Cooperation, a partnership between Maersk and Hapag-Lloyd, has announced a strategic shift in its Asia-UK services. The London Gateway port will now be prioritized over Felixstowe, following the recent unveiling of their 2025 schedule. This new 'hub and spoke' model aims to achieve 90% service reliability by February 2025. Instead of direct calls, smaller transhipment vessels will service most European locations, enhancing operational efficiency.

#### **Air Freight Updates**

In the realm of air freight, new security regulations have been implemented for shipments entering the USA under the Pre-Loading Advance Cargo Information (PLACI) requirements. These regulations necessitate additional data elements for compliance and are effective immediately. Shippers targeting the USA are advised to familiarize themselves with these new rules to prevent potential delays.

#### MAERSK SAILS LARGE CONTAINER VESSEL WITH DUAL-FUEL METHANOL ENGINE

- 1. Maersk Halifax has become the world's first larger container ship to be converted into a dual-fuel vessel sailing on methanol.
- 2. The retrofit was completed in 88 days at the Zhou Shan Xinya shipyard in China. It included adding methanol fuel tanks, a fuel supply system, extending the vessel's length by 15m to 368m, and increasing its capacity to 15690 TEU. Following successful sea trials, Maersk Halifax has returned to service on the trans-Pacific route.
- 3. This milestone is part of the company commitment to achieving net zero emissions by 2040 and demonstrates how retrofitting existing vessels can reduce emissions.





#### INDIA TO BUILD BIGGEST PORT?

#### **KEY FEATURES**

- Depth and Capacity: Vadhavan Port will feature a draft depth of 16.5 meters, allowing it to accommodate large container ships, including Panamax and Capsize vessels. The natural depth of the surrounding waters reaches up to 20 meters, making it one of the deepest ports in India.
- ▶ Infrastructure: The port will include multiple container terminals, liquid berths, and multipurpose cargo facilities. Initial plans involve constructing four container terminals, each with two berths
- ► Investment: The estimated cost for the construction of Vadhavan Port is around ₹76,220 crore (approximately \$9.1

billion), with funding coming from a public-private partnership between the Jawaharlal Nehru Port Authority and the Maharashtra Maritime Board.

#### **ECONOMIC IMPACT**

The development of Vadhavan Port is expected to significantly boost the local economy by creating jobs and enhancing trade capabilities. It will facilitate smoother cargo movement and improve logistics for businesses in the region, ultimately contributing to India's maritime sector growth.

#### **TIMELINE**

Construction is anticipated to begin in **January 2025**, with the port expected to become operational by **December 2029** This timeline reflects the strategic planning involved in establishing a major port that meets international standard.

# India-Russia Trade Relations Strengthened with Launch of Chennai-Vladivostok Maritime Corridor

On 25th November, Union Minister Sarbananda Sonowal announced the successful launch of the Chennai-Vladivostok Maritime Corridor, marking a significant leap in India-Russia trade relations.

#### **About the New Corridor**

Spanning 5,600 nautical miles, this ground-breaking route is set to revolutionize maritime connectivity between India and Russia's Far East, slashing transportation time and opening up new trade possibilities.

#### **Key Highlights:**

- **Operational Status:** The corridor is already active, with container ships transporting crude oil, metals, and textiles to Indian ports.
- **Time Savings:** The transportation time has been reduced by up to 16 days, cutting the journey from over 40 days to just 24 days.
- **Strategic Importance:** The port of Vladivostok, located just 50 km from the China-Russia border, plays a crucial role in this new trade route.

This new maritime corridor is expected to enhance economic ties and foster stronger bilateral relations between India and Russia.



## **India Modernizes Maritime Sector with Coastal Shipping Bill, 2024**

On December 2, 2024, the Government of India introduced the Coastal Shipping Bill, 2024, in the Lok Sabha. This significant legislative move aims to modernize and streamline the shipping industry, enhancing traffic at major ports, improving maritime efficiency, and providing critical support to domestic shipping companies.

#### **Key Highlights of the Bill**

- **Reduction of Bureaucratic Hurdles:** Indian-flagged vessels will no longer require trading licenses for coastal trade, simplifying regulatory processes.
- **Increased Participation:** The bill encourages domestic shipping operators to play a more active role in both coastal and international trade.
- **Alignment with Global Standards:** It ensures that Indian vessels are competitive on the global stage by aligning regulations with international norms.
- **National Coastal Shipping Database:** A centralized database will be introduced to enhance transparency and information sharing within the industry.

Shri Sarbananda Sonowal, Minister of Ports, Shipping, and Waterways, emphasized the potential of coastal shipping, highlighting India's 7,500 km coastline and its strategic proximity to major global shipping routes. He noted that the bill would significantly boost the maritime sector, making it more efficient and competitive globally.
